Gainful Employment SSN Conflicts

This information is intended for the person in your organization who is responsible for working with the National Student Loan Data System (NSLDS). Please ensure the appropriate person receives this update.

Introduction:

Final regulations published in the Federal Register on October 29, 2010, require schools to report certain information about students who are enrolled in Title IV eligible educational programs that lead to gainful employment in a recognized occupation (GE Programs). On September 26, 2011, the National Student Loan Data System (NSLDS) began accepting GE Program data from schools for award years 2006-2007 through 2010-2011. The identifying information for a student is the same as is used for all records in NSLDS - Social Security Number (SSN), name, and date of birth.

There is, of course, the possibility that a school may attempt to submit GE Program information for a student whose SSN matches a record that already exists in NSLDS, but either the name or the date of birth do not match. When that happens, NSLDS will not accept the GE Record and will return the record to the institution for resolution. Our instructions to schools in these cases are first to determine if, consistent with their institutional records, the student identifiers they attempted to submit are correct. If they are not, the school will need to resubmit the record with the correct identifiers. If the school believes that the identifiers submitted are correct, it must work with the data providers that submitted the NSLDS existing records to attempt to resolve the conflict.

We are providing institutions with an SSN Conflict page to help them identify the data providers that submitted the existing NSLDS records. This technical update explains this tool and how the use of it by schools will affect NSLDS data providers.

We ask that, as a guaranty agency, you assist schools in understanding why the student identifiers do not match the identifiers previously submitted to NSLDS by your agency and determine if the conflict can be resolved. In some instances resolution will also need the


cooperation of the Federal Family Education Loan (FFEL) lender or lender servicer that provided the original identifiers to the guaranty agency.

We appreciate your assistance in helping schools resolve issues that prevent them from loading the required GE Program data.

SSN Conflict Page

The SSN Conflict page allows users to identify those data providers that have previously reported on an SSN that conflicts with records the school may be trying to submit to NSLDS. Data providers may receive calls from schools requesting assistance in understanding the issue with the SSN they are trying to report. The data provider will need to assist the school in understanding that an SSN conflict can occur due to another student using the same SSN, a name conflict, and/or a differing date of birth.

The SSN Conflict page is located under the Aid tab on the [NSLDS Professional Access](#) Web site.



The SSN Conflict page displays a list of the data provider organizations that have records in NSLDS for that SSN. Any or all of the organizations listed may need to be contacted by the school for assistance in resolving the SSN mismatch problem.
