New GA Loan Exit Counseling Summary Report

This information is intended for the person in your organization who is responsible for working with the National Student Loan Data System (NSLDS). Please ensure the appropriate person receives this update.

Introduction

On March 28, 2010, we enhanced the [NSLDS Student Access](#) Web site to offer a new exit counseling tool for federal student loan borrowers in both the William D. Ford Federal Direct Loan (Direct Loan) and Federal Family Education Loan (FFEL) programs. This new tool provides a single exit counseling session for Direct Loan borrowers, for FFEL-only borrowers, and for borrowers who have received a combination of loans from both programs. In addition, we enhanced the [NSLDS Professional Access](#) Web site to offer Guaranty Agencies (GAs) a new Loan Exit Counseling Completion report to identify borrowers who have completed the Loan Exit Counseling session. This technical update provides information on a new Loan Exit Counseling Summary Report for GAs.

Exit Counseling Summary Report

GAs have access to a new summary-level report of student borrowers whose loans they guaranty or service. This report provides data to determine students' completion of a loan exit counseling session, but not the contact information details provided during the session. To request the report, log on to [NSLDS Professional Access](#) Web site. The report is available from the Report List page accessed from the Report Tab. Similar to the Loan Exit Counseling Completion Results report, it can be obtained on request (ad-hoc). The report can be requested either by Date or SSN, depending on the need of the GA.

Both summary reports (By Date or By SSN) are available in either standard fixed width or pre-formatted report. The extract or pre-formatted report is sent to the Student Aid Internet Gateway (SAIG) mailbox associated with the User ID requesting this report. The message class used is based on request parameters.

- EXSMFFOP – Summary extract with ‘Extract’ as the report Type
 - Report ID*: EXTCD3 (by Date), EXTCS3 (by SSN)
- EXSMFMOP – Summary pre-formatted report with ‘Report’ as the report Type
 - Report ID*: EXTCD3 (by Date), EXTCS3 (by SSN)

***Note:** Report IDs are identified as part of the header record of all ‘Standard’ (Fixed Width) extracts and on the upper left-hand side of pre-formatted reports.

Loan Exit Counseling Summary By Date

The Date option provides the requested Loan Exit Counseling summary results by date range, either by selecting a "Beginning Date" and an "Ending Date" or by selecting a set number of days in the past, for the “Completed in Past” option.

As shown below, complete the parameters for the output Type of Extract or Report. The user can specify a particular school OPEID and branch ID, leave the asterisks (*) for all schools and school branches, or enter a six-digit school OPEID and leave the asterisk (*) in the School Branch ID field to receive loan exit counseling summary records at the six-digit OPEID level. The user can also specify a particular Lender ID and/or Lender Servicer ID, or leave the asterisk

(*) for all lenders and/or all lender servicers associated with the GA code. The user can also designate a date range or leave the default dates to receive all cumulative records, or select a Completed In Past (10, 30, 60, 90 and 120 days) option. The user may also choose a sort order of SSN or Last Name/First Name.

Loan Exit Counseling Summary By SSN

The SSN option provides the requested Loan Exit Counseling summary results by borrower SSN. Up to 19 separate SSNs can be requested at a time.

As shown below, complete the parameters for the output Type of Extract or Report. The user can specify a particular school OPEID and branch ID, leave the asterisks (*) for all schools and school branches, or enter a six-digit school OPEID and leave the asterisk (*) in the School Branch ID field to receive loan exit counseling summary records at the six-digit OPEID level. The user can also specify a particular Lender ID and/or Lender Servicer ID, or leave the asterisk (*) for all lenders and/or all lender servicers associated with the GA code. The user can enter up to 19 student SSNs. At least one SSN must be entered.
